- 10. Report on District Operating Plan
 - a. Report from Director of Special Services Paula LaChance

Spring is a busy time for our preschool team. They are working on new B-3 referrals in preparation for the start of next school year. They are also preparing for our preschool screening which is scheduled for March 20^{th} . All the slots are full. Now that Oakdale has a full-time social worker, she has begun social skills lessons with all the grades. She is utilizing the RULER Program, which is an evidenced based approach to social and emotional learning (SEL). There are preschool lessons focused on students understanding their feelings using colors (red – I feel angry; green I feel happy). These lessons are short and age appropriate. Teaching RULER is a districtwide program and it we are slowly teaching the preschool students so they will be familiar with the program when they enter Kindergarten.

My staff have begun the 5th to 6th grade transition PPTs. These PPT's will continue to happen until the end of the year so the IEP's reflect services students will receive in middle school. This is also an opportunity for parents to get acquainted with the 6th grade special education teachers at Tyl, get any questions answered and collaborate on best practices for the transition.

b. Report from the Assistant Superintendent – Dianne Vumback

We just completed our state mandated testing on our multi lingual learners. We feel very hopeful about the scores. In particular, the middle level is showing great promise! It is the middle level that is always a bit tricky to motivate the students – often feeling awkward and ashamed of their language deficits or they don't want to be singled out for language acquisition skills. Our district ML coordinator, Faith Emond, worked

with both Principal Gwudz and Assistant Principal Lilienthal to create a positive approach to testing, offering incentives and celebrating successes with the students.

The window for smarter balance testing opens March 25th and I will work with administration on preparing for this important assessment. Our 11th graders are taking the NGSS assessment on March 14th and the.

Next Thursday, March 7th Mohegan is hosting a Family SEL night! The set up involves families picking up a "passport" that will have a schedule and place for them to get a stamp after each session. We are so proud of Mohegan's Social Worker Brianna Strycharz and First Grade Teacher Laurie Shugrue who are organizing this fun, interactive and creative "first ever SEL night".

Stations to visit will include: yoga, meditation, RULER, watercolor breathing activity, coloring, exploring senses and school spirit activities. They have five raffle prizes (free!) that each promote family engagement/togetherness, with themes that include game night, movie night, wellness basket, breakfast basket and a baking basket. Kudos to Principal Klinefelter and his entire team for supporting this wonderful opportunity to encourage family engagement with our schools!

I received a letter form Commissioner Russell-Tucker in response to Wills and my meeting with the CSDE staff to request permission to use the state-approved Open Court Foundational Skills Program as part of a compendium of programs to meet the state's legislation regarding implementation of a one of a list of named programs. Our request was denied. The Commissioner stated that a reconsideration of provisions of CGS 4-181a was not applicable to the waiver process and therefore there would be no reconsideration.

Access to School Cameras by Montville dispatchers – Nic met today with half of the town's dispatchers and will meet with the rest tomorrow to ensure they are fully trained in accessing our school's camera systems in case of an emergency.

Willie is off to a great start as our new director of facilities. He is listening carefully and quickly adjusting to his new position. He has been an excellent resource as we are working to comply with the IAQ and HVAC legislation.
