Meredith,

If the driveway is the only access, I'll need it to be widened to 20' to access large FD vehicles.

Exit signs and emergency lights will need to be installed on all levels.

Interconnected smoke alarms will need to be installed on all levels.

Exterior egress lighting will need to be installed at every useable exit. Lighting shall illuminate the means of egress to an area of refuge.

Fire extinguishers shall be required on each level.

If oil or propane heat, a CO detector shall be installed in close proximity to the heating device.

A Knox Box shall be installed at the main entrance.
