Hi John,

We addressed your comments from last week. I have attached the updated plan sheet for your review. The responses to your comments are shown below in italics.

1)The North Island at the entry by the front needs to be cut back. If there is a vehicle in the other lane the truck will not be able to get by. They will need to have easy turning radius

The radius of the north island at the entry has been increased to allow more maneuvering room for the fire truck to access the site.

2) Northwest Island need to be cut back to make easier access which will create more of issue when snow is on the ground, this will cause the hydrant to be pushed back closer to the Building

The radius of the northwest island has been increased to allow more maneuvering room for the fire truck to access the site.

3) Southwest Island need to be cut back to make easier access which will create more of issue when snow is on the ground, this will cause the hydrant to be pushed back closer to the Building

The radius of the southwest island has been increased to allow more maneuvering room for the fire truck to access the site.

4) Southeast Island need to be cut back to make easier access which will create more of issue when snow is on the ground

The radius of the southeast island has been increased to allow more maneuvering room for the fire truck to access the site.

No parking signs have been included on the plans along the west and south walls of the parking lot to prevent cars from blocking fire truck access to the site.

6) The west wall of the Parking lot has Parking lights and I am concerned if the trucks come around that they will scrape of hit them. Thoughts?

The light poles will be far enough away from the drive aisle that there is no concern of the truck hitting the pole. The arm and light assembly will be at a height that a fire truck will pass under without any conflict.
