- East Lyme and Lyme/Old Lyme combining to establish a JRB
- Review distributed packet/any questions or concerns – email Barb
- Possible Assistant Superintendent/Principal to sit on JRB
- JRB panels are generally voluntary
- Cost effective

- Councilman McFee went to town attorney
- Waiting on Rules and Procedure meeting
- Motion was made by Officer Moorehead that the Chairman or Vice Chairman has the authority to speak on behalf of the Board when not in session or to write letters “on behalf of the Board”, 2nd by Tim Shanahan. All those in favor – 1 opposed, 7 agreed
