The Town of Montville will be utilizing a virtual FreeConferenceCall service to allow the public to attend the Board of Assessment Appeals Meeting on September 12, 2020, 9:00 a.m. **All persons claiming to be aggrieved by the doings of the Assessor of the Town of Montville with regard to motor vehicle assessment on the Grand List of October 1, 2019 must physically attend the meeting to present their appeal to the Board of Assessment Appeals. Appellants may not present their appeal remotely.**

On March 14, 2020 Governor Ned Lamont issued an Executive Order 7B suspending in-person open meeting requirements, and to hold such meetings or proceedings remotely by conference call, videoconference or other technology.

Written comments must be emailed to the Town Clerk at townclerk@montville-ct.org at least **1 working day in advance** by close of business on Friday, September 11, 2020.

Written comments may not be read in their entirety, but rather similar messages may be aggregated or paraphrased for submission.

Live audio comments may be made via **FreeConferenceCall.com** by calling **605-313-5935 (Access Code 401237#)**. Comments will only be accepted at times designated for public comment by the Chair of the meeting. The Montville Rules of Procedure, decorum, timeliness and suitability shall be followed and enforced in the same manner as if the meeting were held in person.

All owners of motor vehicles registered in the Town of Montville, CT are hereby warned that the Board of Assessment Appeals of the Town of Montville will meet in open session at the Montville Town Hall on Saturday, September 12, 2020 in Town Council Chambers commencing at 9:00 a.m. for the sole purpose of hearing appeals related to the assessment of motor vehicles.
